### **Community**

## Village Green

The reseeding has been more successful and the planners have accepted it The Cherry Tree Croft decision is imminent. In order for the dispute to be over, the existing exit must be blocked and the new access used. The PC and J.Cawood will then have to sign the legal documents. At this point we can begin to develop the Green. P.Dewhurst is to draft a letter to J.Cawood asking him about the reinstatement of the wall. This will be circulated to PC members.

#### **Toilets**

Driers and soap dispensers now working. Successful so far.

### Broadband

There had been problems with the original contractor but BT say they will sort out the problems by the end of the year.

## **Traffic and Transport**

Parking has again been a huge problem. I.Swales, A.Bradley, N.Heseltine and J.Todd will form a committee and meet with the National Park to form a strategy. The Park has a new draft plan so may have more flexibility than previously. Double yellows on Finkle Street, passing place signs and more frequent opening of parking fields were discussed. Once we have a strategy we can then approach Highways. We will talk to the Listers and the YHA again. The PC will order some more traffic cones.

## **Maintenance and Repair**

Potholes have been reported on the Lee Gate Rd and on Gordale Rd. P.Dewhurst to contact Highways. Many other holes have been repaired recently and in good time.

## **Environment**

There has been an offer to donate a bench. Hanlith has a suitable site although care needs to be taken with overhanging trees. P.Dewhurst is to write in reply.

We have requested a new dog waste bin from CDC but have had no reply. This is for the Cove Road. We will also request one near the entrance to R.Hudson's field . P.Dewhurst will write again and copy in A.Sutcliffe and J.Todd. The PC will also provide one near Miresfield which will be emptied by volunteers.
