| Cyclists lost or injured and not returning to the start/finish.             | N/A      | Competitor          | No         | Medium   | <ul style="list-style-type: none"> <li>• Emergency telephone number to be supplied on the map or C/P descriptions.</li> <li>• The phone must be on, charged or power supply with charger and attended at all times during the event.</li> <li>• Marshals to be present at strategic points to aid or assist any riders as required if competition area is very large.</li> <li>• All competitors to be checked in and out at the start / finish.</li> </ul>                                      |
| Cyclists crashing or falling during the event. Special consideration areas? |          | Competitor/Public   | No         | High     | <ul style="list-style-type: none"> <li>• Any unusual hazards to be marked on the map.</li> <li>• BSI approved, cycling specific helmets must be worn by all competitors during the event.</li> <li>• Competitors to carry minimal first aid kit and whistle.</li> <li>• Emergency telephone number (as above).</li> <li>• First aid equipment at the event centre.</li> <li>• Back-up support vehicles available.</li> <li>• Major accidents to be covered by the emergency services.</li> </ul> |

| Dangers from forestry work being carried out.              |          | Competitor / Staff         | No         | Medium   | <ul style="list-style-type: none"> <li>All forestry signs to be complied with by competitors.</li> <li>Areas of high risk to be marked on the map or designated "Out of Bounds"</li> </ul>  |
| Equipment failure  | N/A      | Competitor                 | Yes        | Low      | <ul style="list-style-type: none"> <li>All cycles to be in good working order, random checks.</li> <li>Riders to carry spares and tools for minor (common) repairs</li> </ul>   |
| Poor weather conditions                                    |          | Competitor / Staff         | No/Yes     | Medium   | <ul style="list-style-type: none"> <li>Weather to be monitored prior to the event and start. If the weather conditions are deemed to be unsuitable in exposed areas, then removal of high level check points to be considered.</li> <li>Competitors to carry waterproof clothing.</li> </ul>                    |
| Farms and farm stock                                       |          | Competitor/ Staff / Public | No         | Low      | <ul style="list-style-type: none"> <li>If event passes through farm yard, owner to be informed.</li> <li>Consideration to be taken during special seasonal times (lambing etc.) to warn riders of extra care needed to safe guard livestock.</li> <li>BMBO rules require competitors to close gates.</li> </ul> |
