### **YDNPA - Update from Area Ranger: W Locke**

- Jury is out about whether to add stones next to the Cawden footpath steps to prevent walkers from using the muddy areas adjacent to the steps.
- The cove path is being upgraded
- The works to the Pennine way path to Black Hole bridge are nearly complete and there are plans to create a turning circle for the Trampers and to add a seat.

### **Risk Assessment & Rock Falls on Parish Land**

- MH has completed Risk assessments for The Cove, Gordale and The Plantation.
- DH presented an update on the situation at Gordale. Full report is here

- The BMC have offered to do a roped inspection. The site is too large to inspect in one visit. They hope to do the 1<sup>st</sup> inspection over the next couple of weeks. The drone footage will be very useful. They will send us an initial assessment. There won't be any climbing now until April when the cliffs dry out. The recent rockfall likely to be caused by tree roots penetrating and enlarging joints in the rock and high wind speeds rocking the trees. This coupled with alternating very dry and very wet spells of weather. There is highly likely to be other rockfalls following this event.
- The inspection will cover more than just the climbing areas and will extend to the potentially unstable slopes above the cliffs.
- After we receive the report from the BMC and after Webbers carry out the tree work, we will probably need to have a professional risk assessment of Gordale. It would be unrealistic to ask them for measures to reinforce the slopes but advice about whether the rockfall risk is a 10 yr/50/yr,100/yr event would be very useful. We have several contractors that we could approach for quotes.

- The risk at the Cove is far less but trees are still present on part of the rock face. BMC will also inspect that as part of their regular assessment and will send report.

The BMC have been extremely helpful.

- Discussion with Kate Hilditch (YDNP) re footpath closure
- Currently a 21 day closure, can extend easily for another 21 days and can also request a 6 months closure but needs to be advertised first. KH will progress this as we are unlikely to have completed the assessment before the 21 day closures expire.
- We will keep YDNP informed about contractor dates
- Discussion about potential more permanent footpath diversion. It would be safer for the footpath to be moved over towards the bank of the stream. This could be done by building a low wall with some extra signage.

#### **Tree work.**

- Webbers will start at Gordale over the next few weeks.
- Advice has been received from Natural England about adding herbicide to prevent re growth.
- Excellent Habitat Regulation Assessment report from Jane and David.
- Natural England will visit and give advice about ongoing management and how much felled timber we can leave on site.
- Need to be aware of the Ecological importance of the site and trampling and timber removal could cause significant degrading.
- YDMT can also help with Management and would be useful to liaise with the NT. We will do a habitat management report for The Cove
- We could also approach the Woodland trust to help us manage it in the future.
- We may not need a felling licence
- We will ask Webbers to deal with the trees near Cromwell Cottage as part of the initial phase.

#### **Update from County Councillor, Cllr. S. Myers**

The wall collapse in Gargrave is causing problems with traffic congestion. It should be eased when the road is temporarily realigned which should happen quickly

There are plans to restrict access to the refuse facility at Swindon Quarry and in Settle to residents only. Registration will be online but will also be available in other ways

NYCC is likely to need to make savings of £60 million each year for the next 3 years.
